FOR STUDENTS COMMUTING BY PRIVATE VANS (TP BLOCK)

REMINDER

Dear Parents,

I would like to once again convey to you that the safety and security of all the students enrolled is school's prime concern. Time and again you have been cautioned regarding engaging private vans to commute your children to and from school for the following reasons :

- 1) Most of the vans are plying with private numbers which is illegal.
- 2) They do not fulfil the permit conditions of Delhi Transport Authority.
- 3) Drivers do not have Public Service Vehicle Badge numbers and Commercial license.
- 4) They do not have a valid Insurance.
- 5) Vans do not have fire extinguishers.
- 6) These vans do not adhere to the colour norms and display as specified by the authorities.
- 7) These vans are overcrowded (carrying two times the number of children actually permitted).
- 8) Many vans pick up students late from school.
- 9) Majority drivers do not have a police verification done nor do parents have their ID proofs and photographs.
- 10) Many of them stop their vans unsafely and allow children to get down from doors which open on the main road.
- 11) Many vans drivers shuffle their van children with children of other vans.
- 12) The vans have also posed problems of sexual abuse, use of abusive language and bullying.
- 13) Drivers are rash, cross speed limits and disobey traffic rules.
- 14) Van Drivers allow students to sit on CNG cylinders covered with planks or converted into seats.
- 15) Many vans are not registered with transport department.
- 10) They do not have first aid kits.

For all the above reasons parents have been discouraged to hire private vans for their wards. However, if you wish to continue with their services, you may fill the form given and the undertaking and submit it along with the following documents of the driver:


- a) Copy of adhaar card
- b) Van RC
- c) Ensure that the van driver wears grey uniform with name plate and public service vehicle badge.
- d) The van driver should positively wear I card daily to school. The I card must have his name, address, Mobile number and Van number.
- e) Ensure that the van drops your ward to school between 8.15 a.m. and 8.30 a.m. in the morning and picks up between 12.30 p.m. and 12.40 p.m. in the afternoon.
- f) One parent by rotation should accompany the children in the van in the afternoon to ensure safety of the child.

I would like to once again reiterate that the school maintains no connection with any private van transporter. Use of private conveyance is totally at your discretion. The school may not be held responsible for any untoward incident occurring outside the school premises or in the private conveyance.

The school urges you to use school transport. If interested in availing the school transport, kindly send an application through your ward to the respective class teacher. In case seats are available on the existing routes, the school may try to accommodate your ward in the bus or else will be considered for the next session.

I seek your support and cooperation in ensuring the safety and security of your ward in school.

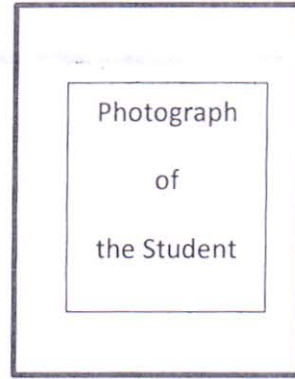
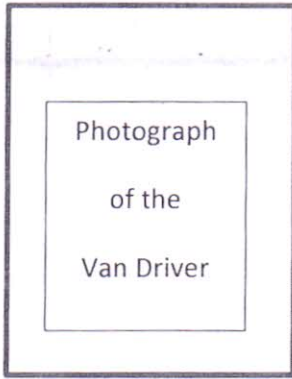
